- ***UP TO 4 PARTICIPANTS ON A TEAM***
- ***NO DISTRACTING, INTERFERING, OR ASSISTING WITH OTHER TEAMS***
- ***EVERYONE GETS TO KEEP THEIR PUZZLES***
- ***KEEP YOUR BELONGINGS UNDER YOUR TABLE, PLEASE KEEP COMPETITION FLOOR UNCLUTTERED***
- ***HEADPHONES AT LOW VOLUMES ARE ALLOWED***
- ***NO PHONES ON THE TABLE AND MUST BE OUT OF SIGHT/USE DURING COMPETITION***
 - ***LEAVE THE ROOM IF YOU ARE USING YOUR PHONE***
- ***NO EXTRA LIGHTING: NO HEADLAMPS, FLASHLIGHTS OR PHONE LIGHTS***
- ***NO SNACKS; DRINKS WITH COVERS ONLY***
- ***BREAKS AS YOU NEED BUT LEAVE THE ROOM. THERE ARE NO SCHEDULED BREAKS***
